This is an opportunity for an ambitious journalist to report on a wide range of climate stories, from thawing permafrost, to marine heat waves and forced village relocation. This reporter will tell the stories of the people affected and communicate to the audience why they should care.

The reporter's stories may also reach a national audience. As part of the grant, the reporter will work with an NPR climate editor regularly, who will coordinate and collaborate with our station on regional coverage. The Climate Change Reporter will attend a three-day training in Washington, D.C., in 2023 with other station reporters and the climate team.

Alaska Public Media delivers television, radio and digital content and is the source for NPR radio and PBS television for Southcentral Alaska. We are also stewards of the public media statewide news collaboration with 25 public media partners. The reporter will uphold the highest journalistic standards and ethics and work professionally with Alaska Public Media colleagues and the public.
